Payment is due with your registration form. Once accepted, there will be no refunds. There is no charge for community service groups or non-profit groups. Because of staging limitations, we must restrict the number of parade units to 100 or less. The Committee reserves the right to deny any application. A late fee of \$50 is applied to all applications received after the deadline.

PLEASE NOTE: The parade starts at Shannon Parkway and proceed east on 145th St., ending at Cameo Ave. ALL UNITS MUST ENTER FROM DIAMOND PATH AND 145th UNLESS SPECIFIED BY COMMITTEE.

Vendors wishing to sell items along the parade route must apply for a permit by July 1. The permit fee is \$125.
